

Rushville Boarding Kennel

Boarding Agreement

This is a contract between Rushville Boarding Kennel, (hereinafter called "Kennel") and the Pet Owner whose signature appears below, (hereinafter called "Owner") for services for _____, (hereinafter called "Pet").

Payment is expected for services at the time of checkout. Owner agrees to pay the rent for boarding in effect on the date Pet is checked into the Kennel as posted on the Kennel's website. Pets picked up after 12:00 noon will be charged the full boarding rate for that day. Owner agrees to pay all costs and charges for special services requested, plus all veterinary expenses deemed appropriate by Kennel for Pet during the time it is in the Kennel's care. Kennel shall attempt to contact Owner before incurring such veterinary services as may be required by Pet's health and/or behavior.

Owners to provide all current vaccination records for Pet to include, Rabies, Distemper and Bordetella (1 year minimum)

Kennel agrees to exercise all due and reasonable care to prevent injury and illness to Pet. However, in the event of illness or injury, the Owners and Employees of the Kennel shall not be held personally liable for such injury or illness.

It is expressly agreed by Owner and Kennel that Kennel's liability shall in no event exceed fair market value for the Pet boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said Pet while it is in the care of the Kennel. Owner agrees to be financially responsible for Kennel property damaged by Pet. Responsible costs for damage will be payable upon checkout of Pet.

If Pet becomes ill or if Pet's behavior is endangering itself, humans, or other animals, Kennel, in its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the Owner of the Pet first; however, in the event of an extreme emergency, the well-being of the Pet comes first. The undersigned Owner hereby gives the veterinarian complete authority to treat Pet in whatever manner deemed necessary. Owner will be responsible for all veterinary charges upon release of the Pet. Owner also gives full authority for the treating veterinarian and their associates to discuss with Kennel any aspects of any illness or injury that the Kennel has presented for treatment.

Owner agrees to notify Kennel if the Pet's stay will exceed scheduled checkout date. In the event the Pet is left in the care of the Kennel for (7) or more days past the scheduled pickup date without notification from Owner, the Owner agrees that the Kennel may contact appropriate authorities and/or make any arrangements necessary to remove the Pet from the Kennel premises. In the event of such situation, the Owner waives all rights to the Pet and waives all statutory or legal rights with respect to the Pet.

Owner authorizes the use of pictures of their Pet taken while participating in Kennel activities on its website or in other promotional materials.

By signing this Agreement and leaving Pet with Kennel, Owner certifies to the accuracy of all information given about Pet to the best of their knowledge. Owner specifically represents that he or she is the sole owner of Pet.

By signing this Agreement, Owner indicates that he or she has read and accepts all policies listed in this agreement as well as all policies on Kennel Schedule of Services and Fees listed on Kennel website rushvilleboardingkennel.com.

This contact contains the entire agreement between the parties.
